


What do educators, recycling advocates, yoga instructors, and occupational therapists have in common? They are all BCABVI community partners who contribute their individual expertise to help us tackle complex problems impacting people who are blind and visually impaired. Each person's role is distinct but our collective impact is greater than we could ever have alone.

With their help, last year we successfully created programs that went beyond basic vision services to address the bigger issues of aging in place, emotional wellness and youth empowerment. Volunteers provided **1,843** hours of service with an in-kind value of \$45,964.

In a smaller organization, volunteers have even more of an impact because we simply wouldn't have the manpower to do everything we want to do for our clients and community without their help. We believe volunteers don't get paid, not because they're worthless, but because they're priceless. At FOX Rehabilitation, a core pillar of our mission is to believe in the strength of people to achieve what they once thought impossible. Through a model of geriatric physical, occupational and speech therapy housecalls, we give our patients the tools that they need to be safe and independent as they age in place. It has been wonderful to work with BCABVI because they mirror our passion for service and the delivery of painstakingly excellent clinical care. They are a tremendous ally and resource to our practice and our community.

Our clinics provided 441 low vision evaluations, follow-up appointments and low vision therapy training sessions. We distributed 398 low vision aids and loaned an additional 50 devices to

#### low income patients through our lending library.

People need to be able to use what they learn in our clinics in their home. The additional training and support provided by organizations like Fox Rehab will further encourage independence and patient success in their everyday environment.



I was surprised the first time I walked down the street and overheard comments about my white cane. People didn't know what it was for. The second time it happened I knew I had to do something about it. As part of the foundation, I started the Bookin' for Lookin' 5K Race event as a way to raise awareness about people with blindness and visual impairments and to raise money for non-profit organizations that help them. I chose BCABVI as one of the two nonprofits the foundation supports because it is a phenomenal place to get services. The updated facility and clinic mean I don't have to travel to Philadelphia to access expertise and technology. Over the past six years I have seen what BCABVI has done and believe it will have continued success in the future. In addition to the financial support provided by my foundation. We conducted 21 community presentations, 12 adult and 7 children's education programs, participated in 3 health fairs, and 1 local cable program interview last year to raise awareness

#### and educate our community.

Our diverse audiences included nursing students, business association professionals, senior citizen groups, 3rd grade students, medical staff, community organizations, foundations, potential clients and the general public. When these varied audiences advocate within their individual peer groups, increased awareness reaches all parts of our community.

**66** The purpose of the New Jersey Lions Eyeglass Recycling Center (NJLERC) as an organization is to collect, clean, neutralize, and designate the prescription of used eyealasses and to store and package them for distribution to needy groups and individuals throughout the world. BCABVI is a centralized collection site where local Lions Clubs can drop off glasses collected from across Bucks County. By using a centralized location, it reduces the resources needed for collection and makes the program more efficient."

BCABVI partnered with 20 local Lions Clubs throughout Bucks County to collect 40,569pairs of used eyeglasses to be recycled for groups and individuals in need.

BCABVI provided 5,700 hours of support groups, life skills sessions, and social/recreational activities at our Newtown facility and community sites throughout Bucks County.

A visual impairment can limit people's ability to perform everyday tasks, affect their quality of life, and to interact with the surrounding world. Feeling understood and socially connected to others who share similar experiences reduces the stress and anxiety that often accompanies vision loss and replaces them with feelings of confidence and hope for the future.

By recycling scrap metal, 611 Metals takes what could be considered as waste and changes it into a resource which can be continuously reused to preserve the environment. At the same time we help provide funds in support of programs for people who are blind and visually impaired. Any great partnership benefits everyone involved and that is what we have found with BCABVI.

# Second Look Newtown Thrift Shop has recycled over 100,000 lbs of metal and textiles creating value from every donation while protecting our environment

Everything generously donated to our thrift shop from community members is used in some way. Whether it is sold in the store, online, or recycled it contributes to the unrestricted income available to support our programs and services. Last year Second Look Newtown Thrift Shop generated income equal to 40% of our annual operating budget with sales increasing by 11% from the prior year.


# Statement of Financial Position




BCABVI ended fiscal year 2018/2019 in a strong financial position having sufficient liquid assets in reserve to cover 4.5 years of operating expenses.
